### Data Protection

The following guidelines serve as information for the application process for volunteers of the German Open Ju-Jutsu 2021. Referring to Art. 13 of the DSGVO - Duty to provide information when collecting personal data.

#### Responsible:

The 3 Team Event Service gUG - Kennedystraße 32 in 63477 Maintal - is responsible for the data collection and processing.

#### Purpose of processing:

The data requested are stored or processed by us for the best possible selection and classification of your application.

The division is made by 3 Team Event Service gUG.

#### Necessary data:

When applying, we process data from you, which we need for the purpose of the application. These are your contact details, clothing size and special knowledge. Of course, data that you leave voluntarily will be treated as well.

#### Legality of processing:

We see your application as a volunteer as a kind of contractual relationship between the respective volunteer and the 3 Team Event Service gUG. The processing of your data takes place in order to fulfill contractual obligations in accordance with the legal basis of Article 6 (1) (b) DSGVO, according to which the processing is necessary for the establishment, implementation or termination of this contract.

#### Data storage / data deletion:

Should we need volunteers for future events we would like to keep your data available and contact you if necessary. For this we ask for compliance with the enclosed consent form for further processing. Your data will be deleted if the purpose for which the data was collected has ceased, eg. B. upon termination of the contractual relationship, if no statutory retention periods preclude deletion.

#### Transmission of your data to third parties:

Possibly we use strictly instruction-bound service providers, who use us e.g. in the area of EDP, supporting security and with whom separate contracts for order processing were concluded. In addition, we may need to share your information with third parties to the extent necessary to fulfill legal obligations. The data are not transmitted to companies from countries outside the EU.

**Privacy Rights:**

With regard to your personal data, you have the right of information, deletion, restriction of processing and data portability and, in the case of incorrectness, of rectification (see articles 15 - 20 GDPR). As an affected person, you have the right to complain to a data protection supervisory authority if you believe that the processing of your data violates data protection laws. The right of appeal may in particular be applied to a supervisory authority in the member state of the place of stay or the place of the alleged infringement.

**Data protection officer:**
